


Here Are Some Of The Top Headlines Making Caribbean News This Week:

REGIONAL

A new report is warning that several Caribbean countries including Jamaica without shoreline defenses could permanently lose five percent or more of their cities to sea-level rises by the end of the century.

"Without shoreline defenses, under a worst-case warming scenario by the end of the century, five percent or more of the following cities are projected to fall permanently below sea level, namely, Guayaquil, Ecuador, Barranquilla, Colombia, Santos, Brazil, Rio de Janeiro, Brazil, Kingston, Jamaica, Cotonou, Benin, Kolkata, India, Perth, Australia, Newcastle, Australia and Sydney, Australia," said the report.

New hyper-local data released Tuesday by Human Climate Horizons, a collaboration between the United Nations Development Programme (UNDP) and the Climate Impact Lab (CIL), notes that the extent of coastal flooding has increased over the past 20 years as a result of sea level rise.

It said as a result, 14 million more people worldwide now live in coastal communities with a one-in- 20 annual chance of flooding with global greenhouse gas emissions (SSP2-4.5 projected by the end of the century to expand this one-in-20 floodplain to areas currently populated by nearly 73 million people.

SURINAME

The Suriname government

has sought to clarify its position regarding the ongoing war between Israel and the terrorist group, Hamas, saying it "favors a two-state solution based on the borders proposed in 1967."

The United Nations Security Council Resolution 242, adopted on November 22, 1967, was an effort to secure a just and lasting peace in the wake of the Six-Day War, fought primarily between Israel and Egypt, Jordan, and Syria

The resolution included an Israeli withdrawal from territories occupied in the conflict, a just settlement of the refugee problem, and the termination of all claims or states of belligerency.

Speaking in the National Assembly, President Chandrikapersad "Chan" Santokhi said that a temporary ceasefire is now in place and he is hoping that a solution will be reached through peaceful means I dealing with the situation in the Gaza.

CARICOM has called for an immediate ceasefire in Gaza, the immediate release of all hostages and for their humane treatment at all times in compliance with international law.

JAMAICA

The human rights group, Jamaicans for Justice (JFJ), has described as "disturbing and distressing" a video on social media showing a police officer kneeling on the chest of an 11-year-old male primary school

student.

In a statement, the JFJ called on the Jamaica Constabulary Force (JCF) and Commissioner of Police, retired major general, Antony Anderson, to provide a thorough account of the encounter.

The incident is reported to have taken place after the child's father was involved in an altercation with the police during a traffic stop.

The JFJ said the incident allegedly unfolded as the child, visibly shaken by his father's high-stress encounter with law enforcement, reacted emotionally.

Media reports said that the student was "allegedly pepper sprayed, thrown to the ground, knelt on by an officer, and refused water to alleviate some of the pain endured due to the encounter."

The JFJ called on the JCF to take swift and decisive action against the officers involved, ensuring they are held accountable

for their actions, saying it "emphasizes the importance of proportionate responses by law enforcement based on the specific circumstances of each situation.

It is also urging members of the public to come forward with any additional information that may aid in the investigation.

GUYANA

Senior officials from the United States Army and the Guyana Defence Force, (GDF), recently engaged in discussions, underscoring the strength of their military partnership, according to the US Embassy.

The leadership teams from the US Army's 1st Security Force Assistance Brigade (SFAB) and the GDF explored upcoming activities, including strategic planning sessions aimed at bolstering both nations' military readiness and their ability to address security threats.

The SFAB, a specialized unit within the US Army, plays a crucial role in advising and assisting partner nations. Since 2022, it has collaborated with the GDF on numerous joint training exercises, reinforcing their tactical and operational capabilities.

SFAB advisors expressed their gratitude for the opportunity to train with the Guyana Defense Force, emphasizing their commitment to deepening this partnership in the coming weeks and months.

These discussions come at

a crucial time as Guyana faces tensions with Venezuela over the ownership of the mineral and forest-rich county of Essequibo. Vice President Bharrat Jagdeo recently announced upcoming visits by teams from the US Department of Defense, reaffirming Guyana's commitment to maintaining peace and working with allies to address regional challenges.

ST. KITTS

The St. Kitts-based Eastern Caribbean Central Bank (ECCB) says its Monetary Council has approved the replacement of the Queen's image on the Eastern Caribbean (EC) currency.

"The proposed replacement is an emblem which depicts the flags of ECCB member countries," the ECCB said in a advertisement, saying "this image provides more holistic reflection of the ECCU (Eastern Caribbean Currency Union)"

The ECCB serves as the central bank for the islands of Antigua and Barbuda, Dominica, Grenada, St. Vincent and the Grenadines, St. Kitts-Nevis, Montserrat and Anguilla. The successor to the British West Indies dollar, it has existed since 1965.

Maduro's Madness - Venezuelan Voters Support Referendum That Guyana's Essequibo Is Theirs

On Sunday, Dec. 3rd, more than 95 percent of Venezuelan voters supported a claim in a referendum that the Essequibo region of Guyana belongs to Venezuela. That's almost threefourths of the new, oil rich South American CARICOM nation, the only English speaking nation in South America. Venezuelans who turned out to vote in the Nicolas Maduro called national referendum overwhelmingly backed Venezuela's territorial

The referendum has ratcheted up tensions between the two neighbors. Critics

of the Venezuelan president say he called the non-binding referendum to whip up nationalist fervor and distract from calls for free and fair elections to be held.

Still the vote is seen as largely symbolic but it asked voters if they agreed with creating a Venezuelan state in the Essequibo region, providing its population with Venezuelan citizenship and "incorporating that state into the map of Venezuelan territory." It is unclear what steps Venezuela's government would take to enforce its claim, however.

Venezuela has long claimed the land, which it argues was within its borders during the Spanish colonial period. It dismisses an 1899 ruling by international arbitrators that set the current boundaries when Guyana was still a British colony, and Venezuelan President Nicolas Maduro has cast the referendum in anti-imperialist sentiment on social

Guyana has called the move a step towards annexation and an "existential threat.'

media.

Guyanese President Irfaan Ali visited troops in Essequibo and dramatically hoisted a Guyanese flag on a mountain overlooking the border with Venezuela. Ali has affirmed Guyana's commitment to navigating the border controversy with Venezuela through a path of peace, hope,

and dignity. Addressing potential actions by the Venezuelan government, President Ali warned that ignoring international laws would cause great injustice to the

He also highlighted Guyana's responsibility in the midst of the controversy, noting that the nation has to lead by example during this time.

'We don't need to do what the Vice President of Venezuela and Maduro are doing. We don't need to tell lies, spread propaganda, and create mischief... That is not leadership," the Guyanese leader posited. Ali has also called on the government of Venezuela to act with dignity and in the best interest of its citizens.

The International Court of Justice, based in The Hague, ruled before the vote that "Venezuela shall refrain from taking any action which would modify the situation that currently prevails in the territory in dispute." It plans to hold a trial in the spring on the issue, following years of review and decades of failed negotiations. Venezuela does not recognize the court's jurisdiction on the issue, however.

Guyana, and British Guiana before it, have administered Essequibo for over a century.





Justice (ICJ) on Dec. 1st issued a significant ruling on the Guyana/Venezuela border dispute, stating that Guyana has met all the necessary requirements for provisional measures concerning Venezuela's

The International Court of

December 3rd consultative referendum. This referendum pertains to Venezuela's claim to the oil-rich

Esseguibo County of Guyana. The Order of the Court was unanimous, with all of the sitting Judges voting in favor of it. The Order states: "Pending a final decision in the case, the Bolivarian Republic of Venezuela shall refrain from taking any action which

Guyana Border Dispute would modify the situation that currently prevails in the territory in dispute, whereby the Cooperative Republic of Guyana administers and exercises control over that area."

> Both Venezuela and Guyana have been instructed to abstain from any actions that could exacerbate or prolong the ongoing dispute before the court, making it more challenging to reach a resolution. The ICJ's orders were unanimous, and Judge Joan Donoghue, the court's President, delivered the ruling.

Guyana had sought the intervention of the United Nations' top court to impose temporary restrictions,

potentially leading to the removal of certain questions from the referendum. Guyana perceives this vote as an 'existential threat" that could enable Venezuela to annex Essequibo.

Earlier this year, in April, the ICJ affirmed its jurisdiction to address the border controversy between these two South American nations. However, Venezuela does not recognize the court's jurisdiction, which could potentially delay a final decision for years.

Venezuela contends that the border with Guyana, a former colony of The Netherlands

Jamaica Achieves Financial Milestone With Inaugural Jamaican Dollar **Linked International Bond**

The Jamaican government has achieved a significant financial milestone by issuing its firstever Jamaican Dollar (J\$) linked international bond, totaling J\$46.6 billion or US\$300 million. The bond, issued on November 3, was oversubscribed 1.4 times and consists of Senior Unsecured Notes due in 2030. registered with the United States-based Securities Exchange Commission, (SEC).

This groundbreaking operation marks the Government of Jamaica's inaugural J\$-linked transaction in international capital markets and aligns with the GOJ's objective to open local currency debt issues to international investors. The move aims to reduce the GOJ's exposure to USD-denominated debt, as both interest and principal payments are linked to the value of the Jamaican dollar.

However, it's essential to note that while the bond is denominated in J\$, debt service payments to bondholders will be in US\$, determined by the

average of the prevailing J\$ exchange rate over the ten business days before each payment date. This arrangement means that international investors in this bond assume Jamaican Dollar exchange rate risk.

The bond issuance represents the second phase of a liability management

from this Jamaican dollar-linked bond being used to repurchase outstanding US\$-denominated

Moody's, the international credit rating agency, published an Issuer's Comment, stating that the use of the J\$ linked Bond issuance proceeds to buy back outstanding USDdenominated bonds will reduce "the government's exposure to foreign-exchange risk, which is a credit positive." Over time, this reduction in exchange-rate risk is expected to address one of the sovereign's key credit challenges.

In the initial phase of the transaction, Jamaica invited offers to tender for cash, targeting its 7.625 percent Notes due 2025, 9.250 percent Notes due 2025, and 6.750 percent Notes due 2028. This offering achieved several significant milestones, marking the first J\$-linked transaction by the Jamaican government and demonstrating the success of local currency deals in

international markets.

International investor participation in the J\$ link bond reached 93.5 percent, with 6.5 percent coming from domestic investors. This represents the highest participation rate by international investors in a local currency issue in 2023 globally. The bond is also noted for having the lowest coupon and yield for a local currency-linked global bond transaction in 2023 to date, marking Jamaica's first return to the international capital markets since 2019.

Dr. Nigel Clarke, Jamaica's Finance and Public Service Minister, led a Jamaican delegation on an investor road show in London and New York related to the bond issuance. He emphasized the transaction's significance in opening new possibilities and frontiers for Jamaica, highlighting the country's improved macroeconomic fundamentals and monetary policy transparency.

Dr. Clarke stated that

tapping international investors for local currency-linked debt enhances Jamaica's funding sources, broadens financial diversity, and paves the way for more international issues in the future. The government's ability to alter the currency mix of the national debt is expected to strengthen the country's resilience and financial stability.

This landmark development represents a substantial policy dividend resulting from Jamaica's economic progress and commitment to monetary policy transparency, central bank independence, and low, stable, and predictable inflation as a monetary policy objective.

Jamaica's inaugural J\$linked international bond marks a significant step towards financial independence and economic growth, offering new opportunities and strengthening the country's position in the international financial market.

Trinidad Nears Agreement With Maduro As Guyana Confronts Venezuela At World Court

In a significant development, Venezuela is on the brink of granting Shell (SHELL) and the National Gas Company of Trinidad and Tobago a license to exploit a lucrative offshore natural gas field, Reuters reported.

This venture aims to facilitate the export of natural gas to Trinidad and Tobago, as informed by sources close to the matter.

Simultaneously, Guyana has been actively engaging with the International Court of Justice (ICJ), also known as the World Court, in a long-standing territorial dispute with Venezuela. The crux of the matter involves Venezuela's contentious plans for a December 3 referendum that could influence rights over a resource-rich territory, an issue that has fueled discord between the two neighbors for decades.

In April, the World Court affirmed its jurisdiction over this dispute, setting the stage for what might be a protracted legal battle. Guyana's representative, Carl Greenidge, has voiced concerns that the referendum could significantly undermine Guyana's territorial integrity, potentially annexing a vast expanse of its land into Venezuelan territory.

Guyana's plea at the Hague, described by Venezuelan Vice President Delcy Rodriguez as exaggerated and aggressive, seeks to prevent this referendum, citing potential threats to its sovereignty.


Amidst these tensions, Trinidad and Tobago's Prime Minister Keith Rowley confirmed ongoing negotiations for the gas license. Energy Minister Stuart Young's expected visit to Caracas underscores the earnestness of these discussions. This license could significantly benefit Trinidad's gas processing and petrochemical sectors, while offering Venezuela a vital source of revenue. The two nations, following a recent U.S. authorization, are keen to expedite cross-border energy projects.

The focus of these negotiations is the Dragon field, a gas reserve in Venezuelan waters near the maritime boundary with Trinidad, estimated to contain up to 4.2 trillion cubic feet of gas. The proposed partnership envisages Shell holding a 70 percent stake and Trinidad's NGC the remaining 30 percent.

While some details remain unresolved, the impending agreement, expected to be finalized soon, marks a potential turning point in the energy landscape of the region.

Barbados Prime Minister Joins Global Center On Adaptation Advisory Board

The Prime Minister of Barbados, Mia Mottley, has joined the Advisory Board of the Global Center on Adaptation, (GCA). This significant appointment follows an invitation extended by Ban Ki-moon, former Secretary-General of the United Nations and current Chair of the GCA Board, and Professor Patrick Verkooijen, CEO of the GCA.

Prime Minister Mottley, in her acceptance of the role, emphasized the urgency of addressing climate change for vulnerable nations. "The current system is failing those increasingly impacted by climate change. I am eager to collaborate with the GCA to push governments towards more urgent action, particularly in doubling adaptation finance by 2025," she stated.

Ban Ki-moon praised Prime Minister Mottley for her efforts in reshaping the global financial system, particularly through the Bridgetown Initiative. This initiative aims to create new financial instruments and reform existing ones to finance climate resilience and achieve the Sustainable Development Goals (SDGs). "Prime Minister Mottley's innovative approach is vital in ensuring resilient finance reaches the most climatevulnerable states. I am looking forward to working with her at the GCA," Ban Ki-moon

remarked

Professor Patrick Verkooijen highlighted the dire situation of the world's poorest and most climate-vulnerable nations, which are trapped in a cycle of debt and climate disasters. He noted that the economic cost of climate disasters in developing countries could soar to \$580 billion annually by 2030. "Working with Prime Minister Mottley, we aim to break this cycle by significantly increasing investment in climate resilience. This is crucial for reducing future costs associated with climate disasters," Verkooijen stated.

The GCA, founded in 2018, is an international organization dedicated to accelerating action and supporting adaptation solutions in response to climate change. Operating from its unique floating office in Rotterdam, the Netherlands, the GCA has a global network with regional offices in Abidjan, Dhaka, Beijing, and an upcoming office in Nairobi set to open in January 2025. It partners with public and private sectors to broker solutions at both international and local levels, focusing on the most vulnerable communities affected by climate change.

(CONTINUED FROM PAGE 4) and the United Kingdom, was fraudulently imposed by the British, accusing them of a "land grab." Conversely, Guyana maintains that the border was established through arbitration on October 3, 1899, by an arbitration panel (Arbitral Award of 3 October 1899).

The Anglo-Venezuelan Arbitral Tribunal met in Paris, France, 122 years ago, giving its award that defined the border between Venezuela and then-British Guiana. For over half a century, Venezuela adhered to the 1899 Arbitral Award. However, in 1962, Venezuela asserted that the Essequibo area of Guyana was within its borders, particularly escalating after ExxonMobil discovered oil in Essequibo in 2015.

In response to this situation, Guyana initiated a case against Venezuela at the World Court in 2018, seeking confirmation that the border was established through arbitration between British Guiana and Venezuela in 1899

Under the framework of

the 1966 Geneva Agreement between the two nations, the Secretary-General conducted Good Offices processes from 1990 to 2017 in an attempt to find a resolution to the border dispute.

On January 30, 2018, then-Secretary-General Antonio Guterres, following a thorough evaluation of the developments in 2017, selected the ICJ as the mechanism to address the controversy.

Essequibo constitutes nearly two-thirds of Guyana's territory, with approximately 125,000 of the nation's 800,000 inhabitants residing in this area.

In the substantive case, Guyana aims to secure a final and binding ICJ judgment, confirming the validity and binding nature of the 1899 Arbitral Award, which delineated the land boundary between British Guiana and Venezuela, and asserting Essequibo as Guyana's territory.

Haitian National Makes FBI Miami Top Ten Most Wanted List

The FBI Miami Field Office recently added a new name to its top ten Most Wanted List, intensifying the search for a dangerous individual.

Special Agent in Charge Jeffrey Veltri of the FBI Miami office emphasized the threat posed by the fugitive, Haitian born Vitel'Homme Innocent. "He is a menace to the island and a threat to American citizens," Veltri stated. Innocent is one of only 532 individuals to ever appear on the FBI's most wanted list.

Vitel'Homme is a Haitian national and leader of the Kraze Barye gang, which operates

Tabarre areas of Haiti and actively participates in kidnappings for ransom, extortion, and car thefts.

A substantial reward of \$2 million is being offered for information leading to Innocent's arrest and conviction, a figure significantly higher than the usual bounty for most fugitives on this list. The FBI believes Innocent was involved in the 2021 kidnapping

of 16 American missionaries in Haiti, which included five

children, the youngest being just eight months old. The hostages managed to escape after 61 days in captivity.

Veltri issued a stern warning about the FBI's commitment to capturing Innocent. "The FBI's resolve will not waver. We will use our full capabilities and will not relent until he is brought to justice," he said.

Innocent is suspected to be the leader of a violent gang responsible for numerous heinous crimes, including the 2022 kidnapping of Americans Jean and Marie Odette Franklin, during which Marie was tragically killed.

The FBI's Violent Crime Chief, James Krieger, highlighted the success rate of capturing individuals on the Most Wanted List, noting that nearly 93% of those listed have been apprehended since the list's inception in 1950. He also emphasized the crucial role of public tips in these arrests, with 163 individuals being apprehended as a direct result of citizen cooperation.

Florida's Insurance Crisis Intensifies As Homeowners Grapple With Soaring Premiums

Frequent natural disasters are leading insurance companies to exit markets, like Florida, where large payouts for destroyed homes are becoming common. "I never thought I would see houses that are completely uninsurable," noted insurance broker Robb Lanham to Yahoo Finance recently.

The crisis is exacerbated by climate change, which is increasing the severity and frequency of hurricanes. These stronger storms are causing more damage, leading insurance companies to raise premiums to cover the costs. In Florida, for example, home insurance

premiums have skyrocketed by 300 percent in the past five years. The average cost of home insurance in the state is now over \$4,200 annually, more than double the national average.

This steep increase is reflective of Florida's vulnerability to severe storms. Since 2016, the state has consistently reported losses for property insurers, making it a challenging market for insurance companies.

However, Florida is not alone in facing these challenges. States like California are dealing with more frequent wildfires, and areas like Kentucky and

West Virginia are increasingly prone to landslides and flooding, all amplified by climate change.

The insurance crisis is a nationwide issue, with 23 weather-related disasters in 2023 alone causing over \$1 billion in damages each. The First Street Foundation estimates that 35.6 million homes across the U.S. could face more expensive or unavailable insurance policies as insurers withdraw from high-risk

Political responses to the crisis have been varied. In Florida, Governor Ron DeSantis, currently a presidential candidate, has been criticized

for his handling of the situation. Swanson, the new Sanibel Island resident, accuses DeSantis of neglecting both the insurance and climate change crises.

The insurance industry in Florida faces additional challenges due to the high volume of lawsuits against insurance companies, which is particularly damaging to smaller insurers. DeSantis signed a law to make suing insurance companies more difficult, but critics argue this approach doesn't address the root of the problem.

The rising costs of home insurance are just one part of the

broader housing affordability crisis in the U.S., impacting everyone from retirees to young first-time homebuyers. The situation is made worse by high levels of college debt and a challenging job market. Redfin chief economist Daryl Fairweather predicts an increasingly difficult path for Americans striving to enter the housing market.

Of Rape, Hypocrisy And The GOP State Party Chair

The chairman of the Florida Republican Party has stated that he will not step down amid allegations of rape, asserting his innocence in an email to supporters. Christian Ziegler, who did not address the specifics of the accusation, emphasized that he and his wife, Bridget Ziegler, have been targeted due to their prominent roles as political figures.

In the email sent to state Republicans, Ziegler defended his decision not to resign, citing the need to continue their mission despite facing false allegations of a crime. Governor Ron DeSantis had previously suggested Ziegler's resignation to prevent any distractions for the party but Ziegler remains steadfast in his refusal to step

While no charges have been filed against Ziegler, an ongoing investigation by the Sarasota Police remains open. The accusation against him was made by an individual who has known him for two decades and alleges that he forced his way into her apartment and raped her, as per search warrant affidavits.

In his email, Ziegler did not address previous statements he made to detectives regarding

consensual sex with the woman nor his wife's statement about a previous instance of group sex involving the couple and the accuser.

Ziegler asserted the strength of his family and their commitment to withstand the allegations. He did not provide further comments, and calls and messages to the Zieglers for additional remarks went unanswered.

Governor DeSantis' office has not commented on Ziegler's decision to remain in office at the time of this report. The revelation of the rape accusation came after the Florida Center for Government Accountability obtained police reports and search warrant affidavits, leading to public scrutiny and allegations of hypocrisy against the Zieglers, especially regarding their association with Moms for Liberty and LBGTQ+

Bridget Ziegler, an elected member of the Sarasota County school board and an appointee to the board overseeing Walt Disney World's land development by Governor DeSantis, has been accused of hypocrisy due to her involvement with organizations opposing LBGTQ+ causes

despite her husband's rape allegation.

The accuser's identity has been redacted in documents, as is customary in cases of sexual assault. The Associated Press does not disclose the names of possible victims of sexual assault without their consent.

Text messages cited in affidavits suggest that the accuser, the Zieglers, and the alleged victim had initially planned to engage in group sex on a specific date, but the accuser withdrew her participation when Bridget Ziegler was unable to attend. Later that day, the alleged victim claims Christian Ziegler forced himself into her apartment and sexually assaulted her.

Text and phone conversations monitored by investigators indicate that Ziegler initially offered financial assistance to the woman, only to become suspicious that their conversations were being recorded.

During a November 2 interview with detectives, Ziegler maintained that the sexual encounter was consensual and admitted to recording it, deleting the video, and then later recovering it following the rape allegation.

Detectives seized Ziegler's phone during the investigation, but the contents of the phone have not been disclosed to

Nicole Landry: Embracing Jamaican Heritage And Wellness In Atlanta Through 'Journey Of Atman'

Unlike Ontario, Alberta never had a large Caribbean population. Yet, growing up in its capital of Calgary, Nicole Landry had a sense of Jamaica, her father's homeland.

Her father, Neville, is from Kingston, Jamaica's capital, while her mother is Canadian. Her father's mother, Hilda, came from rural Westmoreland parish, once the hub of Jamaica's sugar industry.

"I don't recall there being a strong sense of Jamaican-ness in Calgary at the time, but inside my home was a different story,"

Landry recalled. "My father's love for music ensured that all of the greats often played within our walls. Dennis Brown, Greggory Isaacs, Beres Hammond. So many to count."

"He took great pride in exposing me to our roots and culture. Before starting school, he would often educate me on the things that most western schoolbooks leave out," she added. "The impact of Marcus Garvey, colonialism, and the timeline of Jamaica's independence. In my opinion, Jamaican-ness is a way of life and a feeling. It is everywhere you go because the feeling is so special and

the love is so strong. It's in the joy found in valuing the little things. The power in our communities. The beauty of maintaining our humility in our humanness. Gratitude for the gift of life. When I close my eyes that feeling gives me a sense of peace, and it moves me anywhere I go."

Journey Of Atman, which Landry started in 2020, has 17 scented candles in its catalog. They include Light, Love, Compassion, Abundance and Respect, all of which are available through her website, *journeyofatman.com*.

Landry plans to expand her healing and self-affirmation products with new scents in the spring of 2024.

She is the sole founder of the Caribbean Global Awards, a London-based event celebrating the accomplishments, successes, and contributions of Caribbean businesses, entrepreneurs, and professionals around the world. Healthcare executive, entrepreneur, business consultant, and motivational speaker, Michaelene Holder-March, is driven by her passion to elevate Caribbean greatness.

The Number Of Undocumented Migrants In The US Tops 10 Million

As Donald Trumpeto plans a widespread expansion of his first administration's hard-line immigration policies if elected to a second term in 2024, including rounding up undocumented immigrants already in the US and

placing them in detention camps to await deportation, the Pew Research Center has released new data on the estimated number of undocumented migrants in

the US

According to Pew, there were some 10.5 million unauthorized immigrants in the US as of March 2021. This represented about 3percent of the total U.S. population and 22 percent of the foreign-born population. That was a modest increase over 2019 but nearly identical to 2017.

The new estimates, however, do not reflect the apprehensions and expulsions of migrants along the U.S.-Mexico border after March 2021, as migrant encounters at the border have reached historic highs.

The country with the greatest number of undocumented migrants in the US remains Mexico with 4.1 million or 39 percent of the nation's unauthorized immigrants in 2021.

After Mexico, the countries of origin with the largest unauthorized immigrant populations in the U.S. in 2021 were:

El Salvador - 800,000 India - 725,000. Guatemala - 700,000 and Honduras - 525,000.

Three Central American countries – El Salvador, Honduras and Guatemala together represented 2.0 million unauthorized immigrants in the U.S. in 2021, or almost 20 percent of the total. The unauthorized

immigrant population from the Northern Triangle grew by about 250.000 from 2017 and about 700,000 from 2007.

Venezuela, meanwhile, was the country of birth for 190,000 U.S. unauthorized immigrants in 2021. This population saw particularly fast growth, from 130,000 in 2017 and 55,000 in

Among countries with the largest numbers of U.S. unauthorized immigrants, India, Brazil, Canada and former Soviet Union countries all experienced growth from 2017 to 2021.

The six states with the largest unauthorized immigrant populations in 2021 were:

California - 1.9 million Texas - 1.6 million Florida - 900,000 New York - 600,000 New Jersey - 450,000 and Illinois - 400,000.

In 2021, these six states were home to 56 percent of the nation's unauthorized immigrants, down from 80 percent in 1990.

Meanwhile, the share of unauthorized immigrants in the U.S. workforce was slightly less than 5 percent in 2021, compared with 3 percent of the total U.S. population. Overall, about 7.8 million unauthorized immigrants were in the U.S. labor force in 2021. That was up slightly from 2019 but smaller than every year from 2007 through 2015, Pew said.

Since 2003, unauthorized immigrants have made up 4.4percent to 5.4 percent of all U.S. workers, a relatively narrow range. Fewer than 1 percent of workers in Maine, Montana, Vermont and West Virginia in 2021 were unauthorized immigrants.

Nevada, 9 percent, and Texas, 8 percent, had the highest shares of unauthorized immigrants in the workforce.



"The Government of Mexico reiterates its rejection of any measure that contemplates the


involuntary return of migrants without respect for due process," says the statement from Mexico's secretary of foreign relations.

It added that Mexico "recognizes the sovereign right of any country to decide the public policies that should be implemented in its territory," but Mexico also has a right to defend the estimated 10 million people of Mexican origin in Texas and

"establish its own immigration policies in its territory.

"The Government of Mexico categorically rejects any measure that allows state or local authorities to detain and return nationals or foreigners to Mexican territory," the statement added.

Five Major Implications Of The Chevron-Hess \$53 Billion Acquisition In Guyana

The recent merging of oil and gas companies in the U.S. indicate that energy majors see a long-term future for specific hydrocarbons in the energy transition. Chevron's announcement of their US\$53 billion all stock acquisition of Hess, and ExxonMobil's US\$59 billion merger with Pioneer Natural Resources, is likely the beginning of a wider industry consolidation in which oil majors target independent producers operating in relatively stable jurisdictions with proven light crude reserves, low breakeven costs, and flexible oil supply (i.e., shale wells that can start producing quickly when oil prices are high). Oil majors will continue to prioritize assets that generate significant free cash flows so they can continue paying large dividends to shareholders.

Financing greenfield energy assets in emerging markets has become extremely challenging with the rise of interest rates. Hydrocarbon assets, which most investors are shying away from, and low carbon technologies, some of which do not yet have proven paths to profitability, are struggling to attract investments in developing markets as the risk-return is simply unjustifiable in the current financial environment. Outright acquisitions and mergers, however, have become more appealing, and none more so than the Stabroek Block in Guyana. The biggest discovery in the last decade has an estimated 11 billion barrels of recoverable oil equivalent, with potential to grow even more in the future. This is a multidecade production play, and it signals Chevron's commitment to a long-term hydrocarbon strategy in the Americas.

For years, Hess has known they've struck the jackpot with Guyana, reflected by the upbeat mood internally at the company. They've been seeking a large payday for quite some timewell deservedly so, as Guyana's Stabroek Block has been praised as the best oil find in recent times. In addition to its resource potential, the ExxonMobiloperated block offers highly competitive breakeven costs ranging from \$25 to \$35 per barrel across producing projects. It is located offshore, where there tends to be less direct impact on communities than onshore drilling, and it also operates under a favorable production sharing agreement with attractive fiscal terms.

Five major implications for Guyana

The Chevron-Hess deal will have five major implications for the Guyanese economy, all of which are likely to lead to longterm reverberations for the local oil and gas sector:

1. An accelerated exploration of the Stabroek block

ExxonMobil's \$63 billion dollars in free cash flow in 2022 makes it one of the most wellcapitalized oil and gas companies in the world. The speed of their ramp up in Guyana has been unprecedented, both in terms of time to market and successfully drilled wells. However, with another oil major joining the Stabroek consortium, it is likely that the 10 to 12 wells planned for 2024, and the 35-well exploration campaign announced through 2028, will actually exceed the original numbers.

2. An increase in production estimates for existing wells

While the Stabroek consortium already has one of the most, if not the most, competent, and technical team in the oil and gas industry with ExxonMobil at the helm, there are technological advances that Chevron could bring to the table that could increase production estimates for Guyana (upwards from the 1.2mn projected for 2027). Chevron CEO Mike Wirth discussed their collaboration with AI juggernaut OpenAI noting "We've been working with OpenAI for multiple years now on technologies that could work in our industry," Wirth said. He noted oil giants generate immense datasets on geological characteristics and more. Often times, these innovative technologies are siloed inside companies, with Chevron already suggesting that they will introduce new technical capabilities to the Bakken assets owned by Hess.

3. A more competitive oil and gas sector

Although Exxon will still be calling the shots as the lead operator of the Stabroek consortium, the presence of another American oil major will lead to more collaborative decision making behind closed doors. Chevron will also now be part of the bid made in the recent oil tender by Exxon, Hess and CNOOC, pacifying some of the government's claims that ExxonMobil is the only game in town.

4. Greater Chinese influence outside of the oil & gas sector

Although the third partner in the Stabroek consortium is Chinese (CNOOC), the state-owned oil company has remained in the background during the last eight years of oil development in Guyana. Now, with the presence of two of the largest American oil majors in the consortium, CNOOC's influence is likely to diminish.

In turn, the Chinese government will increase its presence in surrounding sectors such as mining, healthcare, renewable power, and road infrastructure.

5. Greater pressure from the government and the people

With more resources, comes greater responsibility. The Guyanese government will likely highlight this acquisition to show that interest in Guyana remains hot, using the momentum to sign production sharing agreements that are less beneficial for oil companies in the most recent oil auction. The Guyanese people will also be more inclined to see what they can get out of a new major company coming into the country, both in terms of jobs and greater concessions. Despite the Wall Street Journal recently reporting that Guyana is booming, the reporting also raised questions on how the material improvement is flowing to ordinary Guyanese. It is expected that there will be more public pressure for improved living conditions in Guyana.

Chevron is bullet-proofing their portfolio against international turmoil

Although Hess' 30 percent participation in the Stabroek consortium was the main reason behind Chevron's acquisition, Hess also produces 190,000 barrels per day in the Bakken Shale Play where it owns 465,000 acres of land. The Bakken formation is both more mature and smaller than the Permian basin, signaling less room for growth, but the abundance of land means Chevron could drill new wells in new locations as old wells mature. This flexibility, during a time of geopolitical turmoil, is exactly what Chevron is looking for as it seeks to bullet-proof its portfolio against unstable regimes and international conflicts.

Chevron also announced that the Bakken asset will provide a constant level of production, and strong cash flows, for many years to come. In fact, if the number of rigs remain constant, at four, Chevron estimates that the Bakken acquisition will have at least 15

years of inventory. Although the Bakken has high half-cycle breakeven costs, at U\$58 per barrel, Chevron's resources means that it faces less pressure to stick to modest production increases like many other shale producers. Its deep pockets, and ability to keep providing returns to shareholders, means that Chevron can afford to take riskier bets.

Remembering Neville Garrick

In a 1999 interview with the Jamaica Observer newspaper, Neville Garrick recalled his first meeting with Bob Marley. It was 1974, Marley had just launched a solo career and Garrick was arts director for the left-leaning Daily News newspaper.

Garrick said the Rastafarian reggae singer made him a bold

"Him sey, 'yuh nuh waan come work fi Rasta.' And I said 'yes', and that's how everything started," he recalled.

Garrick, who designed several of Bob Marley and The Wailers' gripping album covers, died on November 14th of cancer in Los Angeles, California. He was 73 years old.

One month earlier, he was awarded the Order of Distinction, Jamaica's sixthhighest honour, but illness prevented him from traveling to Kingston to accept. Garrick last visited Jamaica in March to work as a consultant for 'Bob Marley: One Love,' the Paramount Films movie about the reggae king, scheduled for release in February, 2024.

'Our hearts are broken as we come to terms with this loss. Neville in his own words 'coloured the music' but for us, he coloured our lives. Our hope is that his work will continue to be enjoyed and celebrated around the world," read a release from his family.

The affable Garrick's first major project for Marley was Rastaman Vibration,' the 1976 album, that produced hit singles such as the title track, 'Roots, Rock, Reggae,' and 'Who The Cap Fit.'

In August, 'Rastaman Vibratio'n was recognized by Billboard Magazine as number 22 on its Best 100 Album Covers of All Time list. Other Marley albums Garrick

designed were' Babylon By Bus,' 'Exodus,' 'Kaya,' 'Survival' and 'Confrontation.

After Marley's death from cancer in May 1981, Garrick was appointed head of the new Bob Marley Foundation. Two of Marley's children hailed the man they knew from childhood on social media.

Ziggy Marley posted: "@ nevillegarrick spent the last year with us from England to Jamaica working on his good friend @ bobmarley biopic. His energy was high his affect was positive advising the director and the whole production.

"He wanted to make sure it was done right. He was the light of the production everyone loved hearing his stories and heeding his insights. Without him it could not have been done. It was a continuation of the work he did for my father and the strong friendship they had with each other."

He continued: "I've known Neville since I was a little boy and grew up with him around, to have spent these moments with him working on @onelovemovie meant more to me than can be explained at this time. Having my father's close friend around was a special experience and knowing we became good friends is the bonus. nuff love to his children and friends we can truly and happily say his legacy will live on. Thank you Garrick. JAH"

Cedella Marley, Marley's daughter, posted: "Fly away home Uncle Neville.3

Jamaica Prime Minister Andrew Holness also took a moment to reflect on Garrick's legacy. In his post, he said, "... His timeless creations continue to resonate globally, a testament to his enduring legacy."

Neville Garrick is survived by three children, three grandchildren and one brother.

Beenie Man Among 2023 Reggae Grammy Nominees

Beenie Man, who enjoyed a career resurgence in 2023, is one of five nominees for Best Reggae Album at next year's Grammy Awards, scheduled for February 4 at the Crypto.com Arena in Los Angeles, CA.

'Simma,' his first album in seven years, is nominated alongside Burning Spear's 'No Destroyer;' Buju Banton's 'Born For Greatness;' Bermudian Collie Buddz' 'Cali Roots Riddim 2023;' and Julian Marley & Antaeus' 'Colors of Royal.'

Nominations for the Grammys were announced on November 10th by the Recording Academy.

Beenie Man, 50, is looking for his second Grammy, having won in 2001 with 'Art And Life.' Buju Banton also is aiming for a second win. His first came in 2011 for 'Before The Dawn.'

The 78-year-old Burning Spear, who received his 13th nomination, goes for a hat-trick of wins. He won in 2000 for 'Calling Rastafari,' and in 2009 with 'Jah is Real.'

'Simma' was released by Beenie Man's MD Music Group in August, two years after production on the album ended. But the death of his mother, which resulted in him going through a period of depression,

delayed its release.

The 20-song album contains collaborations with fellow dancehall stars Shaggy, Sean Paul and Busy Signal, as well as Stonebwoy from Ghana and Giggs from the United Kingdom. While he dabbles in Afrobeats and hip hop, Beenie Man told Billboard Magazine that 'Simma' is a dancehall project.

'We're just making music. We do Afrobeats, we do everything. Just make some music. Because people love good music and good music lasts forever. Regardless. Good music outlives you. Trust me," he said.

The Grammy nod was announced one week before the Recording Industry Association of America announced that 'Who Am I,' his 1997 hit song, was certified gold for sales of

over 500,000 units.

That song, from his 1997 album, 'Many Moods of Moses, experienced a revival this year through the #SimSimmaChallenge, which featured Kim Kardashian, Ciara and Kelly Rowland, being asked questions about the deejay.

Collie Buddz gets his first Best Reggae Album call. The singer, whose best-known song is 'Come Around,' gave a creditable performance at the Grace Jamaica Jerk Festival in Miramar on November 12th.

Reggae gained Grammy status in 1985 after years of lobbying. Then known as Best Reggae Recording, it was won by Anthem, by roots trio Black Uhuru. Kabaka Pyramid won in 2023 for 'The Kalling.'

Inner Circle Boosts Trench Town's JaMi Studio With High-End Recording Console

The JaMIN (Jamaica Music Institute) Recording Studio, nestled in the historical Trench Town, the same community where reggae legend Bob Marley once resided, is set to experience a significant upgrade, thanks to the Grammy-winning band Inner Circle. The studio recently received a high-end API Box 2 Summing Mixer and Recording Console, a donation aimed at elevating the facility's capabilities to international standards.

Dave "Prime Time" Green,

the studio manager, expressed his enthusiasm for the new console, stating that it will not only enhance the studio's prestige but also positively impact the surrounding community. The installation, expected to be completed at the end of November, is seen as a step towards changing the negative perceptions often associated with Trench Town.

Green, who has been with JaMIN since 2016, recounted his encounter with Inner Circle in Florida, where he shared the studio's needs with Ian Lewis, co-founder and bass player of

the band. Lewis committed to assisting and followed through on his promise, sending the console from Miami. The state-of-the-art mixing board, valued between \$25,000 and \$30,000, features eight input channels, LED metering, and 24 summing channels, positioning JaMIN as a top tier recording facility.

This upgrade is part of a broader initiative to transform Trench Town, an area marked by gang violence and urban decay, into a hub of creative and positive activity. Green, a past student of Edna Manley College of the Visual and Performing

Arts and a seasoned musician who has played with several international reggae artists, sees the studio as a catalyst for change. He envisions Trench Town gaining respect and recognition similar to Elvis Presley's Graceland, noting its rich musical heritage and the respect it garners internationally.

JaMIN Recording Studio, established in 2006 as part of Dr. Henley Morgan's Agency for Inner City Renewal, offers free access to community members and has been a birthplace for notable music, including Lanz's 2017 hit "She nah Leggo."

Ian Lewis of Inner Circle is impressed with Green's efforts and the studio's role in nurturing talent and providing a positive outlet for the youth.

Inner Circle, formed in 1968 by Ian and his brother Roger Lewis, gained international acclaim with their Grammywinning album "Bad Boys" and hits like "Sweat" (A La La La Long). Their support for JaMIN Recording Studio marks a significant contribution to the legacy of Trench Town and the future of reggae music.

METHOD

 Make a caramel by adding about one pound of the brown sugar to a pot and heating until it begins to melt.

- Add at least a cup on wine and simmer until a dark color is
- Grease and double line an 8-inch bake pan.
- Cream the rest of the sugar and butter until smooth or add to an electric mixer and let it do the work for you.
- Add eggs one at a time (beaten or unbeaten) and mix.
- Add in the set fruit and nuts and stir well.
- · Add enough caramel to make it as dark as desired.
- Sift flour, baking powder and spice together.
- · Add a little at a time and fold
- Mix into a soft dropping consistency by adding a little more of the wine or rum.
- Pour the mixture into the prepared pan and bake in a slow oven at 300 degrees F, for 2 hours on the middle shelf.
- Pour some of the remaining wine or rum over immediately after cake it is baked.
- Repeat 3 or 4 times.
- Serve at room temperature.
- Cake can be kept and preserved all year round by reading rum.

Short Of Breath? It Could Be Interstitial Lung Disease

It is estimated that about 250,000 Americans are living with idiopathic pulmonary fibrosis (IPF) and scleroderma associated ILD, two types of interstitial lung disease (ILD) that can make breathing difficult.

The American Lung Association, with support from Boehringer Ingelheim, is providing support and resources to those impacted by ILD. As part of the educational campaign, they are sharing these important facts and insights:

What is ILD?

Interstitial lung disease is an umbrella term used for a large group of diseases that cause scarring (fibrosis) of the lungs The scarring causes stiffness that makes it difficult to breathe and get oxygen to the bloodstream. Lung damage from ILDs is often irreversible and gets worse over time, however treatment is available to help relieve symptoms.

Who Is At Risk?

While anyone can get interstitial lung disease, many things can increase the risk of ILD or even cause it, including genetics and certain medications or medical treatments, like radiation or chemotherapy. Smoking can not only cause ILDs, but can make the condition much worse, which is why anyone diagnosed is strongly



encouraged to quit. Additionally, people with autoimmune diseases such as scleroderma -- also called systemic sclerosis -- are at an increased risk of developing an ILD. Unfortunately, in the case of idiopathic pulmonary fibrosis, the cause is unknown.

What are the symptoms of ILD?

The most common symptom of all ILDs is shortness of breath. This is often accompanied by a dry cough, chest discomfort, fatigue and occasionally, weight loss.

How Is Ild Diagnosed?

Healthcare providers test for ILD through a chest X-ray or CT scan. A lung function test may be used to measure total lung capacity, which may have deteriorated due to the ILD. In more serious cases, and to diagnose a specific type of ILD, more invasive procedures may be needed, such as a lung biopsy or bronchoscopy, which employs a

small camera located at the end of a flexible tube that takes photos and collects tissue samples of the air passages.

How Can ILD Be Managed?

It is recommended that patients with idiopathic pulmonary fibrosis stay active and eat well. They may also be encouraged to use oxygen therapy as prescribed to help manage their condition. In some cases, the condition can be slowed by certain medications, and occasionally, people with IPF will be recommended for lung transplant.

Where Can Patients Find **Support?**

Two new educational webcasts -- "Newly Diagnosed with ILD" and "Living with ILD" -- will provide education, resources and support to patients and their loved ones. Both webcasts will feature a healthcare provider and patient, and will be made available on-demand after the live showing. Critical resources can also be found through the American Lung Association's Patient & Caregiver Network, a nationwide patientcentric community that connects people living with lung diseases like ILD with critical support,

Study To Explore Exercise's Impact On Aging Brains And Dementia

Physical activity is known to benefit brain health in aging individuals, yet the specifics of its impact, particularly in preventing diseases like Alzheimer's, remain under investigation. Kirk Erickson, a renowned researcher in the field of exercise and dementia, is spearheading an extensive follow-up study at AdventHealth Neuroscience Institute in Orlando to delve deeper into these questions.

This study, named FLAME (Follow-up Longitudinal Analysis of Moderate-intensity Exercise), will re-evaluate over 600 older adults across three cities who previously

participated in the IGNITE study. This earlier trial examined the effects of exercise on brain health, but its results have been delayed due to the COVID-19 pandemic.

Funded by an \$11 million grant from the National Institutes of Health, FLAME aims to conduct a comprehensive reassessment of these individuals. "We want to reevaluate them thoroughly from their physical activity levels to memory tests and MRI scans to plot the trajectory of change and predict future changes," Erickson explained. The ultimate goal of the study is to enable doctors to provide

more personalized exercise recommendations for seniors, enhancing their cognitive health. Erickson emphasizes the established link between exercise and brain health, and through FLAME, he hopes to make a more definitive statement about how exercise behaviours can reduce age-related cognitive impairments.

Caribbean Tourism Thrives Post-Pandemic

Coming out of the recent World Travel Market, (WTM) conference, held in London this past November, Caribbean travel and tourism professionals are optimistic about the prospects for the global tourism industry based on impressive 2023 statistics.

In fact, the WTM Global Travel Market Report in association with Tourism Economics, a travel data company, estimates that world international trips should exceed 1.26 billion in 2023. with 60 percent of that coming from leisure trips.

The Caribbean market is certainly benefiting from these trends and is especially buoyant as numbers continue to tick up post-pandemic. In fact, the Caribbean Tourism Organization, (CTO), representing 25 English, French, and Dutch-speaking Caribbean territories recorded growth for most of its member states in its October 2023 statistical report, as it welcomed its new Secretary-General and CEO, Dona Regis-Prosper, who took the reins in September.

CTO statistics for the period January-September 2023 highlights that out of the 23 member territories that reported international arrivals 22 recorded growth over the same period in 2022, with Aruba at 12.4 percent and British Virgin Islands at a whopping 60.5 percent being examples.

Jamaica and St. Vincent & the Grenadines registered gains in tourist arrivals of 26.8 percent and 43.9 percent, respectively, for the first six months of the year. Part of Jamaica's growth stemmed from its UK visitors last year, recorded at 229,000, becoming the number one destination for British visitors for 2023. The island's Minister of Tourism, Edmund Bartlett, wants to surpass this number and has set a target of 250,000 visitors out of the UK and Ireland by 2025.

ROBUST PACE OF **RECOVERY**

All of this bodes well for a strong regional finish to 2023 as indicated by CTO's Chairman, Kenneth Bryan in a press conference earlier this year.

"It is clearly apparent that even in the face of the devastating blows delivered by the pandemic, as a region we have responded with hope, strength, and the determination

to prevail. Great strides have been made and many of our jurisdictions ended 2022 registering higher than predicted visitor arrivals. That is a clear indication that the sector is bouncing back and hopes are high that the robust pace of recovery will continue

Canadian visitors to the Caribbean also painted healthy numbers for the same four territories mentioned above. Trinidad & Tobago,

at 56.7 percent and Belize at 51.3 percent saw gains from European visitors for January-September 2023. Growth in cruise arrivals was also reported for the 23 reporting destinations. Cruise visitors are expected to continue based on comments by Josh Weinstein, President and Chief Climate Officer at Carnival Corporation. At the Florida-Caribbean Cruise Association's annual conference in November Weinstein said Carnival's portfolio of cruise brands will expand their Caribbean presence to more than 5,000 calls.

These tourism statistics and forecasts indicate that overall, the Caribbean has recovered from its pandemicera downturn, but there is still work to be done. The region must continue to push its unique destinations with a focus on sustainability by promoting its natural, cultural, human, and social resources that are so crucial to the people and economies of all the states in the region.

A Memoir About Grace Under Fire

Just as he was born 'out of place,' Alex Wheatle always felt like an outsider. But it is precisely this non-conformist maverick status that saved him.

Abandoned by his birth mother as a baby and placed in the British foster care system, Wheatle suffered physical and mental abuse which molded him into a 'rebel with a cause,' fighting against the established racist norm in the society he was born in. Unfortunately, this is not a unique story. Many children become trapped in foster care only to come out

scarred by their experiences. But while raw and honest. Wheatle tells his story with sensitivity.

The product of Jamaican parents, neither of whom could take care of him, Wheatle would find solace in Reggae music, rhythms of the 'Sufferah.' Indeed, that's how he saw himself throughout his formative years, being flung from one foster home to another - a victim suffering under Babylon system.

But that would all change as he matured and absorbed the true message of the music: 'Don't be defined by injustice, fight against it.' This was reinforced by mentors like Simeon, his Rastafari 'teacher' who taught him to rise above the system and "make the invisible, visible."

Baptized in the sounds of this hypnotic reggae resistance, Wheatle was now a reggae-head living through the music that would help shape his literary career. Listening to


music by some of his favorite artists like Dennis Brown, Gregory Isaacs, Max Romeo, Bob Marley, Marcia Griffiths, Mighty Diamonds, and reggae toasters U-Roy, I-Roy and Dennis Alcapone, the author would come out on the other

He grew up in Brixton, South London's Caribbean enclave, never knowing his mother, who returned to Jamaica, and with only brief encounters with his father. At just three years of age Wheatle was placed in social care where his physical and mental assault began. His reggae awakening would begin ten years later. This musical journey would sustain him into what would become some of Britain's darkest and bloodiest periods in the struggle for racial justice.

The New Cross Fire is a stain on British history that Wheatle recounts for his readers. On March 2, 1981, a mysterious fire started at a birthday party for a black teenage girl in the New Cross area of London. Thirteen young black people between 14 and 22 were killed. No one was charged, but many suspected

Wheatle's account of the aftermath is searing, taking readers on the road with him as he and many others in black neighborhoods such as Brixton, took to the streets having had enough of police brutality, systemic racism and indiscriminate killing of young

Our breath quickens as he runs from chasing policemen,


black men.

after throwing bricks at them from behind a hastily puttogether barricade. Smoke from burning cars and storefronts stab the air, making it hard to breathe. He jumps a fence; he hides in a huge rubbish bin and we smell the stench of the garbage around him. And we cheer him on.

Raw and gritty at times, yet hopeful because of the fight in him, Wheatle obviously survived to tell his story. Yes, he learned lessons - he had to. Taking such punishment from an early age did indeed leave him angry, scared, impulsive, explosive, and lonely. But with encouragement from those who nurtured him, including St. Giles School for pupils with physical, medical, and learning difficulties, Wheatle learned to forgive.

It is this new-found peace that opened a whole new world to him. The reggae lyrics he wrote as a youth, the poems that helped release him from loneliness, all became fodder for a budding literary career. His young adult novels have garnered him prestigious awards and best-selling recognition. His life story has been memorialized as part of filmmaker Steve McQueen's series 'Small Axe.' For his contrition to British literature, Wheatle was awarded Member of the Order of the British Empire, (MBE) for his invaluable services to the industry.

Indeed, this Sufferah's tale is made visible. It is an inspiring narrative about grace under fire and why negativity should never define us.


Jamaica's Reggae Boyz historic victory in Toronto in November has set the stage for a bright New Year for the team.

Darren Bravo, expressing dissatisfaction over his exclusion from the West Indies One-Day International team, announced his decision to take a temporary break from cricket. In a heartfelt Instagram post, the 34-year-old reflected on his future with West Indies cricket, stating that while he isn't quitting, a hiatus seemed necessary for his career.

Bravo, who has struggled to maintain motivation due to repeated selection disappointments, did not specify the duration of his break. He mentioned the challenges of staying energized and committed in the face of ongoing selection

"I find it increasingly challenging to continue

summoning the energy, passion, commitment, and discipline required to perform optimally and vie for a return to international cricket," Bravo stated.

Despite being one of the region's top players, Bravo was not included in the 15-man squad for the upcoming ODIs against England, despite leading the Super50 Cup with 416 runs at an average of 83. His last appearance for the West Indies was 22 months ago, and he was also
